10	Shake aerosol for at least two minutes, after agitator ball is free
2 *	Apply in cross coats from distance of 250mm from object
3 2122	Allow 3 mins for flash off between coats
4	Apply 2 light coats allowing flash off between coats
5	Dry to overcoat between 10 - 60 minutes
6	After use, turn aerosol upside down and empty valve
